Following the conclusion of the 2023/24 Thursday Preliminary Finals, please find below details regarding Thursday Pennant Grand Final games & venues.

Selectors are reminded that there may be restrictions on player eligibility for Grand Final games, depending on the results of the preceding Finals games for that club (Rule 3.9).

Clubs bringing a reserve player to a Grand Final game may choose to declare the player's name to the opposing club prior to game day.

Clubs are reminded that if there is a protest regarding a Grand Finals game, that protest must be lodged in accordance with Rule 11.2.1 (immediate decision is required) – refer Rule 11.2

The Host Club is responsible for providing a venue Manager of the Day unless another person is appointed by the MBA.
